# Methods and materials for containment and cleaning up

non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Use spark-proof and explosion-proof equipment. Dispose via a licensed waste contractor. Contaminated absorbent material may

pose the same hazard.

Use gloves, goggles, boots and breathing mask. Small amounts do not need special measures. Clean up with water. For large spills remove all sources of ignition. Ventilate area.
